4. Details of our assessment

Thank you for reporting the fire incident as per section 4.3.2 of your permit. details below extracted from your notification.

'Something within the waste ignited causing a small fire inside the bucket of the loading machine, it was extinguished immediately by the machine operator using the on-site hose reel.

The waste material had been brought in on a council owned and operated refuse collection vehicle from a multiple collection round in the Dwyfor area.

For precautionary reasons, the waste material already loaded into the bulk vehicle was unloaded and left outside of the building overnight, as advised by the fire service. Only a very small amount of waste was burnt'.
