## 4. Details of our assessment

This was a routine site inspection carried out by Waste Regulation Officer Amy Henderson accompanied by Senior Waste Regulation Officer Steven White. An unannounced site inspection had been attempted on the 17th August, however the Company Directors were not onsite at this time, so a revisit was arranged for this date (19th August).

On arrival at site Regulating Officers were met by Directors Philip Thomas and Tony Liu, who accompanied us throughout the visit.

The site is currently in the process of applying for a permit variation which is being determined by Natural Resources Wales Permitting Officers. At the time of the site inspection the site has temporarily paused operations in order to install equipment needed for the new processes as part of the applied for variation.

Officers were shown the new equipment being installed and the new site layout. The Company Directors explained to regulating officers how the site plans to operate following the variation being granted. It is hoped this processes will result in the production of a higher quality end material following treatment at the site. It was reiterated to the Directors that new operations cannot begin before the permit has been determined and granted. Any new operations commencing before this time would be in breach of the permit.

Due to the work taking place, no waste was being stored/treated on site at the time of the visit.

A check of waste returns prior to the visit has identified that Q1 & Q2 of 2021 are outstanding. This is a breach of permit conditions and is discussed further below.

### **Category 4 non-compliance score - non-submission of waste returns.**

No waste returns have been submitted since Q4 of 2020. The submission of these returns forms part of the sites permit, condition 4.2.2 states 'Within one month of the end of each quarter, the operator shall submit to Natural Resources Wales using the form made available for the purpose, the information specified on the form relating to the site and the waste accepted and removed from it during the previous quarter'.

A category 4 compliance score has therefore been issued for a breach of this condition. An action has been listed to ensure outstanding returns are submitted by 17th September. Please ensure all future waste returns are submitted within the one month of the end of each quarter, as specified in the permit.
