### Review of Shotton landfill monitoring data for Q2 (April - June 2021)

#### Groundwater Monitoring Data

##### Emissions

- a. Q2 2021 BH9 Ammonia (N2) 3-point moving average 1.3 mg/l\*
- b. Q2 2021 BH1 Zinc 3-point moving average 0.14 mg/l\*
- c. Q2 2021 BH9 Zinc 3-point moving average 0.40 mg/l\*
- d. Q2 2021 BH10 Zinc 3-point moving average 0.12 mg/l\*
- e. Q2 2021 BH9 Nickel 3-point moving average 0.04 mg/l\*

Ammonia limit is 1 mg/l

Zinc limit is 0.04 mg/l

Nickel limit is 0.01 mg/l

##### **\* - breach of 3 point moving average limit**

The current permit has set limits on boreholes 1,2,9 and 10 only.

This is the second quarter in a row for the 3 point moving average breaches of Ammonia, Zinc and Nickel to occur. There is still an unknown with regards to emissions being impacted from historic landfill and/or reclamation/construction materials. Approved revised HRA, suggestions to increase trigger levels.

#### **ACTION**

Need to submit permit variation to increase trigger levels, whilst investigating potential root cause. Previous discussions by previous officers with Tata, states this will be done upon completion of revised gas monitoring and discussions with NRW.

#### Gas Monitoring

External wells data showing majority normal levels of CO2 against ELV. CO2 limit of 1.5% v/v

- a. May 2021 BH1 CO2 level 1.5 % v/v
- b. June 2021 BH1 CO2 level 0.5 % v/v

All CO2 readings showing no breaches.

In waste leachate wells showing elevated CO2:- L6 Max 11.9% L1 Max 2.8%

Waste Received into landfill saw a reduction of almost 50% from previous quarter of 7.64 tonnes of Inert Construction Waste. No Waste removed.
