4. Details of our assessment

Compliance Assessment Report – EPR/LB3039HH - GLJ Recycling Limited

This report considers two inspections of GLJ Recycling Limited, Cwmcarn made by officer Jonathan LEE on the 17th August 2021 and the 27th August 2021.

Permit reference number **EPR-LB3093HH** comprises the following standard rulesets: -

- SR2008 No3 – Household, commercial and industrial waste transfer station with treatment
- SR2008 No23 – Waste electrical and electronic equipment authorised treatment (ATF) excluding ozone-depleting substance

Inspection Observations – 17th August 2021 - 13:00 -13:25pm

Site inspection completed by officer Jonathan LEE. Weather warm and dry. Met with site manager Colin Manning who gave tour of site activities. The site wider GLJ Recycling site was operational at the time of the inspection.

Waste transfer station area of the site inspected. No issues observed. It was noted that the 'old' waste transfer building at the northern end of the site was soon to be removed and that the 'new' building at the front of the site was now the only area of the site used for waste transfer station activities.

Inspection Observations – 27th August 2021

Site inspection completed by officers Jonathan LEE, Luke BURTON and Caerphilly County Borough Council Environmental Health Officer Abbie BROWN. Officers met with site manager/director Gareth JONES. Weather warm and dry.

The site was inspected following recent reports of swarms of flies in the Cwmcarn and Abercarn areas, several other potential source sites in local area were also inspected by officers on this date. No swarms of flies were noted as present on the stockpile of general waste present within the waste transfer station building. Officers discussed that whilst this waste material typically contained a low quantity of organic/biodegradable content that this material should be monitored in case of any swarms of flies. It was noted that the general waste is typically removed from site for disposal on a regular basis to prevent potential amenity or containment issues.

No permit breaches were identified during both inspections.
