4. Details of our assessment

Compliance Assessment Report – EPR/DB3097TJ - GLJ Recycling Limited

This report considers two inspections of GLJ Recycling Limited, Cwmcarn made by officer Jonathan LEE on the 17th August 2021 and the 27th August 2021.

Permit reference number **EPR-DB3097TJ** comprises the following standard rulesets: -

- SR2008 No20– Vehicle storage, depollution & dismantling (authorised treatment) facility
- SR2008 No21 – Metal recycling site

Inspection Observations – 17th August 2021 13:00pm -13:25pm

Site inspection completed by officer Jonathan LEE. Weather warm and dry. Met with site manager Colin Manning who gave tour of site activities.

The site was operational at the time of the inspection, with the shear processing End of Life Vehicles and the shredder processing scrap metal. All wastes appropriately stored and segregated as per permit conditions and site management documentation. Officer LEE discussed dust suppression during dry summer months and it was stated this was being continually monitored by site staff and management. No visible emissions present from shredder activity noted.

Inspection Observations – 27th August 2021

Site inspection completed by officers Jonathan LEE, Luke BURTON and Caerphilly County Borough Council Environmental Health Officer Abbie BROWN. Weather warm and dry.

Site inspected following recent reports of swarms of flies in the Cwmcarn and Abercarn areas, several other potential source sites in local area were also inspected by officers on this date. No swarms of flies were noted as present on the stockpiles of scrap metal, End of Life Vehicles or residual fractions of processed waste from shredding activities present around the site. It was noted that the site had not accepted any food-based aluminium cans in recent times. Officers discussed that whilst the waste light fraction stockpiles contained a low quantity of organic/biodegradable content that this material should be monitored in case of any swarms of flies. It was noted that this waste is typically removed from site for disposal on a regular basis to prevent potential amenity or containment issues.

No permit breaches were identified during both inspections.
