4. Details of our assessment

A Schedule 5 Part A notification was received by NRW on 9th June 2021 in respect of a leak that had been identified, during a routine inspection, on the site main effluent discharge pipeline at the connection point between the site pipeline and the above ground

section of the final discharge pipeline. A follow up Schedule 5 Part B notification was received on 5th August 2021.

The leak had been identified promptly and repaired quickly with minimal loss of effluent to ground (estimated 3m³). Whilst the initial repair was not completely successful, follow up work was carried out immediately and this proved successful. Solutia considered that the specific failure was not likely to be replicated elsewhere on site as the connection type was specific to this joint.

Appropriate measures have been implemented to guard against the potential impact of subsequent failures and also reduce the likelihood of repeat failures, these include;

- increased frequency of PM checks on the joint
- review of effluent pumping to minimise load from surges.

Solutia's response to the incident was timely and comprehensive. This has ensured that the environmental impact was insignificant. In addition the improvements to the PM are proportionate. These will be checked as part of the next audit.

In view of Solutia's response, the absence of environmental impact, the unforeseen nature of the incident and the follow up measures taken, no non-compliances have been recorded.
