Two loads of mixed waste had also been removed from within the treatment building.

Within five days following each removal of mixed waste from within the treatment building, please email Cathy Lloyd with a copy of the waste transfer note showing its removal.

Metal to repair the boundary fence next to residential properties has been ordered. Please notify me when the permanent repair has been carried out.
