4. Details of our assessment

On the 4th August 2021 Officer Robert Andrews assessed permit number 21/57/21/0002. Officer Andrews was accompanied by Kevin Betts (Water Resources Technician) and Wayne Vaughan (Site Operator), DCWW.

Thank you for taking the time to show us around the site and explain your activities. In general, the site appeared well managed and both DCWW representatives were very knowledgeable, competent and helpful. There was only one action point recorded on site.

The abstraction is still in operation for public water supply. However, the upper Neuadd Reservoir point at National Grid Reference SO 0294 1877 has now been removed.

The abstraction is a gravitational supply through valve control. The flow rate meter was checked at the pump house and was recorded as 80.53 mL/d. This corresponded with the telemetry in the control room. The site diary and critical parameter board was correct and completed.

The abstraction graphs and data was received on the 4th August 2021 from Kevin Betts. All readings were in the permit requirements.
