4. Details of our assessment

On 24 September 2020 a site audit of Padeswood Storm Tank was carried out. On the day of our visit the storm tank was empty, and a flow of sewage effluent was being passed forward to Ty Gwyn Sewage Works. The site was in a good state of repair. We were not able to check the discharge point at the watercourse due to overgrown nettles on the river bank.

Following the site audit, pass forward flow data and discharge duration data was reviewed for the period 25/9/19 – 25/9/20. In general the permit pass forward flow rate of 96l/s was being achieved before the storm tank fills as per the permit conditions.

Event Duration Data for 2019 shows that this asset had 88 discharges of settled storm sewage in a 12 month period. This is a concern for the receiving watercourse Black brook, a priority for improvement under the Water Framework Directive. Will this asset be assessed as part of Dwr Cymru's Storm Overflow Assessment Framework (SOAF) project as a 'high spilling' asset?
