4. Details of our assessment

This was an unplanned and unannounced inspection of the Bryn Composting Facility. NRW officers Paul Challender and Jamie Blythin were at the location in relation to the landfill permit and took the opportunity to view a waste transfer being deposited on the composting pad. At the time of the inspection the weather was warm, overcast with a very light breeze.

Prior to entering the permitted area of the composting permit the surrounding areas had been assessed and no odour from the composting operation was detected. The HGV load of green waste itself did emit an odour but once deposited this odour was not detectable outside of the permitted area. The green waste was accompanied by a weighbridge ticket. On enquiring with the weighbridge operator it transpired that these loads were a regular delivery that was covered by a 12 monthly season ticket. The season tickets for the producer were requested electronically after the inspection and all appeared correct. Existing windrows were present on the composting pad.

Waste Returns were also reviewed post-inspection. As previously raised by NRW officer Lara Cubley, there appears to be a significant tonnage discrepancy between waste received and waste removed from Q4 2019 to the present. The discrepancy in tonnages appears to be too high to be represented by the composting material currently deposited within the permitted area. The composting facility has not achieved PAS100 status for some time and NRW has not been informed that PAS100 compliant compost production has resumed therefore, the tonnage discrepancy is not due to waste materials leaving the site as a product. A significant volume of off-specification compost is currently deposited on the land within the landfill's permitted area. Under the Environmental Permitting Regulations waste material should be recorded as waste removed from the composting permit and recorded as waste received by the landfill permit.
