4. Details of our assessment

Natalie Wrangham attended site at Maerdy water treatment works on 10/08/2021. Here I met Kevin Betts, DCWW water resources technician who escorted me on site to inspect the meters for the abstractions from Lluest Wen and Castell Nos reservoirs. I could see that each source had a separate meter (see picture below). I was informed by a worker at the

site that there was currently no abstraction from Lluest Wen due to a water quality issue.



Meter records were sent to Natalie Wrangham by Kevin Betts prior to the site visit on 09/08/2021. These recordings show all daily abstraction readings from 1/07/2020 to 25/07/2021. The readings are all below the maximum daily quantity of 15,917 cubic metres per day and therefore within the maximum annual quantity. The records have been uploaded to the DMS.
