4. Details of our assessment

On 8th June 2021 Officers Emma Tucny, Natalie Wrangham and Michael Launder assessed permit no. 21/57/25/0073.

On arrival, Officer Wrangham spoke with the homeowner who explained that the ponds have not been stocked for around 5/6 years.

We were able to locate the abstraction point at ST 0559 9315, however we were unable to find the abstraction point ST 0582 9304. Due to the land around the other two ponds being overgrown, we were unable to locate the other two abstraction points.

The discharge point from the first pond was at ST05750 93056. The final discharge point was at ST 05965 93000.

Actions by 15/11/2021.

1. Update the permit

- Purpose for which water is authorised to be used has changed as the lakes are no longer stocked.
