Compliance Assessment Report – Biffa Waste Services Ltd, Viking Place (EPR-SP3795FZ)

Officer David WARWICK-BROWN inspected Biffa Waste Services Ltd, (Viking Place) on 25/08/2021 for a routine inspection. The Officer met with Site Manager/TCM Owen Thirkettle, who showed the officer around the site. The weather was overcast and dry for the duration of the visit. Time of inspection: 12:15-

12:40.

Site inspection

There were no issues noted during the inspection on this occasion. The site was highly organised, clean, and tidy. The main unit was relatively empty compared to the previous inspection, and all piles of waste were well under the 4m stack height limit, as required by the FPMP permit condition. The outside yard was approximately half full of recycled waste material, ready to be exported off site.

All waste materials were stored in their clear separate sections as required.

All paperwork was up to date, including the waste returns and the WAMITAB certification for TCM Owen Thirkettle (exp. September 2022).
