4. Details of our assessment

Compliance Assessment Report – Atlantic Auto Salvage Ltd (EPR-BB3099FH)

Officer David WARWICK-BROWN inspected Atlantic Auto Salvage Ltd at 10:45-10:55 on 25/08/2021 for a routine inspection of the operation. The Officer met with Site Manager/Director James Richards at the site.

The weather was overcast/dry at the time of the inspection.

Inspection

There were no issues identified with the site or the operation on this occasion – the site was in a good condition; clean and highly organised. All waste materials were being stored separately as required by the permit, including sealed containers for waste liquids. The Officer noted the use of spill kits being used.

The whole operation was still contained within the unit. The unit contained all waste inside via means of a sealed drainage system, impermeable surface and a lip across the entrance to contain waste liquids in the building.

All paperwork was present and up to date as required by the permit. The current WAMITAB certificate for TCM Gareth Danter-Hill is valid until December 2021.

There are no outstanding issues from the previous CAR form, as all waste returns are now up to date.
