Officer David WARWICK-BROWN visit Lamby Way HWRC on 25/08/2021 for a routine inspection and was

met with Site Supervisor Andrew Morgan. The weather was dry and overcast for the duration of the inspection. Time at site: 13:05-13:20.

Site inspection

There were no issues or breaches to be scored against the permit following the inspection on this occasion. The site was clean and highly organised.

Recent improvements to the site include a new sorting area to the south end of the HWRC, and an increase in the number of visitors per hour from 25 to 30. The site was relatively empty at the time of the inspection, and there appeared to be a steady flow of visitors using the facility.

All waste returns have been confirmed as up to date.
