Officers from Natural Resources Wales inspected the Trelech Sewage Treatment works on the 6th of August 2021.

There were no breaches associated to this permit recorded. Officers did witness a breach on site in accordance with the storm permit, please see CAR_NRW0038741 for information.

Officers inspected the receiving watercourse upon leaving the inspection, no sign of sewage fungus in the watercourse on the day of the inspection.
