4. Details of our assessment

Officer Chris BURGE attended The Old Brickworks Limited at Uskvale Park Estate, Pontypool NP4 0HD at

11:30 on Friday 8th October 2021 to carry out a Drone inspection of Permit site EPR-HB3433RA. The weather conditions were dry and sunny at the time of visit. Officer Burge met with business Director Mr Mark ROBINSON who accompanied Officers around the permitted area.

The Purpose of the inspection was to see what progress has been made with the removal of the large material stick pile in the centre of the site.

Mark explained they have had some issues and he has been unable to process as much material as he would have like. The reasons for this were staff issues, Mark is now the only member of staff on site to operate all machinery. Mark further explained they have had several machine break downs and as will all products there have been delays in getting parts needed for the repairs. In fact, whilst I was on site one machine was being repaired at that time.

It was clear to see that Mark had made some progress and I could see an area approximately 3 meters by 3 meters and 20 meters long had been removed and processed and in place are now stock piles of product ready to leave site.

Officer Burge did discuss with Mark making the product stockpiles more segregated and putting signs on them to identify what the material is, Mark agreed and said he will look to implement this.

Mark also discussed that the Technically Competent Managers certificate has expired and due to personal reasons they have been unable to renew the certificate in time. Mark assured me that this will be rectified within the next month and they are looking to train another person to make sure this doesn't happen again.

ACTIONS

- To ensure Technically Competent Managers certification is renewed as soon as possible and confirm with regulations officer once this has been completed or this will be recorded as a permit breach
- Continue to make progress on the removal and sorting of the large material stock pile as discussed on site
