Sorting of mixed skip waste by hand

Mechanical sorting of plastics and cans

Screening and crushing of inert waste

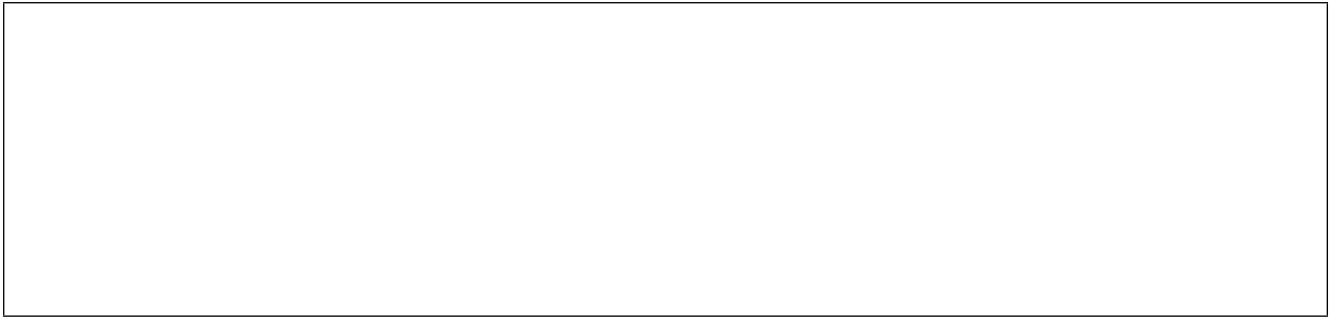
