Any more accurate information on the matters for notification under Part A.	An internal investigation was held, the cause of failure on the 3 rd of August was due to a number of filter bags failing in the dedusting plant, which lead to electric arc furnace dust being emitted directly out through the stack. Up to 100 filter bags had significant damage, with a large number of holes found in each bag upon inspection. The damage occurred over the weekend (1 st /2 nd of August) however, due to a reduction in shift, the operators manning the DED plant were not on site and the burn out of bags was not picked up until Monday the 3 rd . To prevent a reoccurrence of such events, increased inspection of bags are taking place, the CEMS instrument will have an alarm system retrofitted to enable warnings to be sent to contractors and engineers that particulate levels are increasing within the plant. In addition, the temperature of the furnace will be closely monitored to prevent high temperatures from causing damage to DED plant.
