4. Details of our assessment

This Compliance Assessment Report follows a site inspection at Phase 2 - Wrexham Recycling Park undertaken on 8th September 2021 by Rebecca Harwood and Paul Challender.

Garry Smith (PFI General Manager), Thomas Bellis (Assistant Operations Manager) and Dan Sandrof (consultant working on behalf of FCC) were in attendance during the visit.

Following a request by FCC Environment to mothball the acid scrubber on a trial basis, NRW officers visited the site to discuss the proposal and see the scrubber location in situ. A letter to FCC Environment has been sent separately to confirm the trial subject to additional monitoring and information being provided to NRW during the trial period.

The MBT was in operation at the time of the visit and no specific actions relating to its operation were noted.

A consolidated permit has been issued for the MBT following the BRef review. Bioaerosol monitoring is required once every 6 months and it was reiterated that the monitoring should be spaced out across the year.
