4. Details of our assessment

This Compliance Assessment Report follows a site inspection at Wrexham Recycling Parks Transfer Station, Materials Recycling (MRF) and In-Vessel Composting (IVC) facilities, undertaken on 8th September 2021 by Rebecca Harwood and Paul Challender.

Garry Smith (PFI General Manager) and Thomas Bellis (Assistant Operations Manager) were in attendance during the visit.

The IVC, MRF and Transfer Station were all operational at the time of the visit and no specific actions relating to their operations were noted. The MRF operation was observed from the observation window inside the main office building where we discussed various issues, we did not enter or walk the boundary of the MRF during the visit. FCC stated that contamination at the MRF ranges between 3% and 12% depending on the collection round, they work with Wrexham County Borough Council to identify specific issues and round contamination through targeted waste composition analysis.

FCC Environment raised with NRW that since accepting and sorting comingled cans and plastics on site in 2019, input and output sampling as required by The Environmental Permitting (England and Wales) Regulations 2016 had not been undertaken. **This has been scored a CCS4 breach of Condition 3.2.1.** Prior to 2019 the recycle was bulked up and taken to reprocessors and therefore the sampling was not required. FCC have stated that a sampling process has now been implemented.

Action: Please submit your procedure for sampling and reporting input and output waste streams to NRW.

FCC Environment regularly submit quarterly waste returns to NRW, however, these are missing the analysis and information relating to where the waste was taken. **This has been scored a CCS4 breach of Condition 4.2.2.** FCC state that a new sampling process was implemented during July 2021 and the information required will now be submitted to NRW in accordance with the Permit.

Action: Ensure all information is submitted to NRW as part of your quarterly waste returns.
