4. Details of our assessment

Befesa Salt Slags site was visited at 11:00 by Natural Resources Wales (NRW) officer who

met with Stuart Irvine.

Discussions took place at the site office in relation to progress with assessment of pollution sources on site, concerns in relation to deterioration of site infrastructure, the pending determination of the TFS notification for removal of Salts on site prior to onward shipping.

No site operations are still on-going on site. Its still confirmed that only 5 members of staff remain on site.

Discussions around site drainage took place during the site walkover.

The Ammonium Sulphate lagoon has been physically emptied, liner cut-up ready for removal and work to backfill the area is on-going. This no longer poses a threat as a source of pollution. Enviroclear has been contracted to remove the liner, which is classed as "contaminated".

There is no further change in status of material storage. There is still material in the Oxide Plant and also a lot of infrastructure yet to be considered for dismantling. Demolition v Mothballing still under consideration.

Inspection was carried out at the reed bed and open ditch adjacent to the main site road, the drainage around the site compound, main gated entrance, pump house and around the lagoons.

Levels were reasonable within the Surface Water Lagoon, which now only has rainwater ingress, and no process use since the site has stopped operations. There was some headroom if heavy rainfall was to occur, however the surrounding land does still show evidence of high water levels, and does suggest hydraulic connectivity between the Surface Water and Groundwater in that locale.

ACTION

Provide evidence of the liner disposal by means of invoices and transfer notes from Enviroclear by 31/10/21.
