Form S1, Emissions to sewer, 1st January to 30th June 2021, was received on 22nd September 2021, after a reminder was sent to ZF. The report should have been submitted by 28th July 2021. This is the second time that ZF have had to be reminded about submitting mid-year reports on time. It is the operator's responsibility to submit all documentation required in the permit by the due date specified in that permit.

NRW appreciate that business has been difficult recently with the effects of covid and varying supply demands, but ZF should inform NRW when reports are likely to be late.

All parameters were within their respective emission limit values.
