3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

4. Details of our assessment

We have reviewed the following document Permanent Capping Works Construction Quality Assurance Plan and Specification (Document Reference 3761.CAU.XX.XX.SP.Y.7700.A(3) September 2021) which was submitted to NRW on 03.09.21.

Section 1.5.1 viii) of the plan has been revised so that it now states:

'Overlaying of the 300mm thick upper protection layer the restoration soils (including the 300mm upper protection layer) shall be installed to a minimum thickness of 1000mm (800mm subsoil and 200 topsoil). These soils shall be placed to the minimum depth of 1000mm and locally thickened to 1500mm in tree planting areas and tied in with the existing landform and the planting requirements of the landscaping and planting scheme.'

It is noted that Section 3.1.2 (V) states

'The capping works shall comprise:

(V) Placement of restoration soils to achieve a minimum thickness of 500mm.'

As stated in CAR_NRW0037698 (sent 24.02.21), there is a requirement for restoration soils to be a minimum of 1m as per permit/ Waste Recovery Plan and 1.5 m in areas of tree planting.

Action 1: Amend Section 3.1.2 (V) to ensure that restoration soils are placed to a minimum of 1m as per permit/ Waste Recovery Plan and 1.5 m in areas of tree planting.

As stated in CAR_NRW0037698, the operator sent NRW the following document 'Bryn Posteg Landfill, response to Compliance Assessment Report CAR_NRW0036942' on 04.12.20 which addressed a number of comments raised in CAR_NRW0036942 (sent 18.09.20).

However, the CQA plan 'Permanent Capping Works Construction Quality Assurance Plan and Specification -Document Reference 3761.CAU.XX.XX.SP.Y.7700.A(3) September 2021' has not been updated to a consolidated version which includes the amendments and actions proposed in 'Bryn Posteg Landfill, response to Compliance Assessment Report CAR_NRW0036942.'

Action 2: Update the current CQA plan 'Permanent Capping Works Construction Quality Assurance Plan and Specification -Document Reference 3761.CAU.XX.XX.SP.Y.7700.A(3) September 2021' to a consolidated version which includes the amendments and actions proposed in the document 'Bryn Posteg Landfill, response to Compliance Assessment

Report CAR_NRW0036942.'

At present NRW cannot formally approve the CQA plan 'Permanent Capping Works Construction Quality Assurance Plan and Specification -Document Reference 3761.CAU.XX.XX.SP.Y.7700.A(3) September 2021' until Actions 1 & 2 have been completed and an updated CQA plan re-submitted to NRW for review and acceptance prior to commencing construction.
