Records have not been kept. Only one meter reading had been taken and written in the diary, one week before our inspection. The Manager was new in the role and had started to keep records. The readings indicated that 15000 litres had been abstracted within that week, well under the 29 cubic metres per day allowed by the permit.

In future, meter readings must be taken and recorded in line with the permit.
