## 4. Details of our assessment

DCWW Self Reported this incident on 22/9/21 after the blockage of rags had been located and removed. Further update requested on 28/9/21, received from Dan Foreman who confirmed Sewer Abuse letters to be posted in attempt to reduce blockages. Due to human error it was not possible to confirm the duration of the spill as the Telemetry was not replaced appropriately - this was not spotted until the 22nd.
