This was an unannounced visit and an opportunity to get an introduction and familiarisation visit to understand the daily running of the site.

Weather conditions throughout the visit were dry and sunny.

Upon arrival the entrance and yard was free from any mud/debris and was very clean and tidy.





Site was busy at the time with waste material being accepted on site, and processing activities taking place within the waste transfer building. A small amount of material was tipped on the building floor and was being sorted/segreated at the time.

All other wastes were stored in designated skips within the building. This area was generally tidy and organised.

The Electrical items stored must comply with the requirements of the WEEE Directive. Article 8 of the WEEE Directive requires that any facility that stores or treats WEEE under an exemption or permit must, at a minimum, have:

- an impermeable surface
- waterproof covering
- provision of spillage collection facilities

There was no waterproof covering for these WEEE items pictured below in the white tub. Please can you arrange to have a cover for the WEEE waste or store them inside the shed.



No issues were noted relating to noise, odour, litter or pests.

Site diary was checked, no issues.
