4. Details of our assessment

Note: This was not a full Hydro Scheme water compliance check, but a check completed following an incident report on the blocking of the HOF channel.

The HEP scheme is licensed by abstraction licence WA3660008008 and impoundment licence WA3660008009

This report is in reference to the Impoundment Licence

The site was visited by NRW Land Management Officer Paul Morgan on 6th April, 2021. A boulder was found to be blocking the 'Hands off Flow' - HOF channel. This was removed as it was preventing the flow of water through the HOF and is a breach of license condition 4.5 of the impoundment licence WA/366/0008/0009. The obstruction was reported to EO SS on 23.4.2021.

An additional visit was carried out by Swyn Spencer NRW Environment Officer on the 25.06.2021. No further blockage was seen. Paul Morgan also accompanied EO SS on the visit.

Please ensure that the HOF flow channel is kept clear in future as per licence condition 4.5 of the impoundment licence, or NRW may consider further enforcement action. To ensure compliance with the license and protect the environment, you need to make sure that you maintain the intake works in accordance with the specifications and drawings referred to in condition 3.1 of the licence and keep them free from leakage and obstruction at all times.

As a result of this non compliance a CCS Cat 3 score has been issued against license condition 4.5.
