The HEP scheme is licensed by abstraction licence WA3660008008 and impoundment licence WA3660008009

**This report is in reference to the Abstraction Licence**

It was not established on when the blockage was seen whether the hydropower scheme was abstracting. Had the scheme been abstracting whilst the blockage of the hands off flow notch was in place, it is unlikely that the flow regime licensed in condition 9 of the abstraction licence would have been delivered.
