4. Details of our assessment

On 14th October 2021 a routine inspection was carried out at The Star again to assess compliance with permit conditions.

The package treatment plant was switched on and no evidence of odour or spillage was noted.

I could not locate the exact point of discharge, however, the receiving watercourse was inspected upstream and downstream and no evidence of odour, litter or sewage fungus was visible.

At the time of my inspection, you were compliant with permit conditions however there are

some actions required:

Please ensure there is suitable access to the sample point and discharge point at all times.

This is a requirement of your permit conditions.
