This was a routine pre-arranged site inspection by Environment Officer (EO) Paul Challender of Natural Resources Wales (NRW). During the inspection the weather was cool and bright with a light breeze. The Flintshire County Council representatives in attendance for the inspection were Ruth Cartwright, Katie Wilby and Gabrielle Povey. Prior to signing into the site, the perimeter was inspected due to historic windblown, light fraction litter emanating from site. On this occasion no litter has emanated from the permitted area.

On entering site, it was apparent that there was a significant improvement at the site since the last inspection. Quantities of various waste streams stored at the site were dramatically reduced. Also, the quantity of loose waste that was not contained within the waste transfer building, bays or containers was minimal and escapes during tipping were tidied immediately.



The food waste containers were being utilised as per the procedure with no emissions or odour noted at the time. The roller shutter door to the waste transfer building had received repairs and was back on its runners. Extensive netting had been affixed to the external waste bays providing extensive cover to mitigate against windblown litter. The netting in conjunction with reduced levels of externally stored waste had proved highly effective. Only limited loose litter was observed within the permitted area, no litter witnessed by the inspecting officer outwith the permitted area and the operator stated that the need to conduct external litter picks had reduced dramatically. Batteries were now being stored wholly within fit for purpose containers.

After the on-site inspection, discussions took place regarding the new compliance training delivered to staff, changes to the management structure, waste returns and the interaction between the other permitted waste operations controlled by Flintshire County Council.
