TDL Emissions Tracker Schedule 5 Notification - 23rd September 2021

Condition 3.3.5 Breach of Emission Limits at Llanddulas Landfill**Fugitive Emissions Monitoring. - Emission limits**

Requirements - Condition 3.3.5 states the limits for landfill gas arising from the installation shall not exceed the limits set in table S.4.11. Of the permit. The permit requires Flame Ionisation Detector (FID) surveys (TDL in this case), to be conducted monthly at the site boundary and in the immediate vicinity of gas and leachate well heads and monitoring points as specified in the permit.

Findings - The FID surveys over this monitoring period showed that on several occasions, as per the submitted TDL tracker sheet, the infrastructure features highlighted exceeded the permit limit of 1000ppm over the three consecutive month period as agreed..

As a result of consecutive breaches over a sustained period these have been scored a CCS Category 3 breach of permit requirements.
