Natural Resources Wales officer Julia Lloyd met with poultry operator Mr Davies to carry

out the routine poultry inspection at Genauhafod Poultry Unit on Friday 15th October 2021 at 11am.

Thank you for your time during the site visit.

All permit conditions were assessed. We discussed the BAT conclusion report required for the site.
