Unfortunately the fee you sent is incorrect. As you may be aware from our [website](#), our fees are subject to a 2.4% increase as of 01/04/2019. Therefore the fee for this application is £10,240. Please make a payment of £240 to meet this fee and to allow the application to be duly made.

Additionally, I need to ask you for some more information before I can do any more work on it. Please would you complete the following:

- Complete Question 7d Declaration on form Part F1 (i.e. not Question 7e). This must be signed by the operator.
- Provide a revised installation plan with emission points clearly illustrated.
- Confirm the location of the dirty water tank by providing updated plans. The dirty water tank is in different locations on the drainage plan and installation plan.
- The ammonia report makes reference to the use of heat exchangers to reduce the impacts on sensitive receptors. These must be noted in Table 1a of form Part B3 as a Directly Associated Activity, and in the non-technical summary.
