Natural Resources Wales officers Aled Rees and Julia Lloyd met with poultry operator Mr and Mrs Jones to carry out the routine poultry inspection for the site on the 17th

September.

All permit conditions were assessed and found to be compliant, you are currently waiting on the report for the manure analysis for the current flock. Action only, please provide this information by the 17th November 2021.

- **Spreading on own land – manure and slurry nutrient analysis –**

Where manure and slurry is spread on own land, they must be analysed to provide information for nutrient management planning. Records should show that analysis is carried out twice yearly, or once per production cycle where that cycle exceeds six months. The analysis should include available nitrogen, total nitrogen, available phosphorus and total phosphorus. (see guidance section 15 on inspection form)
