4. Details of our assessment

EnerSys have been reviewing the analysis results for samples taken from their ambient air monitors and have discovered some discrepancies which may affect the annual reports for 2019, 2020 and 2021.

Natural Resources Wales (NRW) received a Schedule 5 Notification about this matter on 15th October 2021.

The results from this ambient air monitoring are used by EnerSys to demonstrate to NRW that their management of fugitive emissions is effective. The operator has held an EPR permit for this site since 2005. Historic data from previous reports show that ambient air quality emissions have consistently been well below the air quality standard for this area. NRW have no reason to believe that this has changed and therefore consider that any risk to the environment is insignificant.

In order to ensure that these discrepancies do not occur again, EnerSys propose engaging an accredited contractor to take the samples from the monitors at an agreed frequency and to send them for analysis.

NRW agree with this proposal and would like to see a copy of the contract once it has been awarded.
