4. Details of our assessment

On 19 October 2021 an unannounced inspection as carried out by Sally Wakeford and Michael Edwards. We were accompanied on site by Nick O'Kelly.

The site was well organised, with stockpiles clearly segregated. There had been some issues with wood waste being delayed in offtake, issues which NRW are aware of, although the stockpile appeared still to be a manageable size and not posing any greater fire risk than previously. It is understood that collections would resume relatively soon.

The interceptor was cleaned in Dec 2020, this is done on an annual basis. The outlet was examined and was running clear.

Nick has implemented a site diary which is held on drop box, so is accessible to all. Within this site diary are the considerations for daily checks listed within the permit. Also in the document are links to the waste returns once completed, and other relevant information such as interceptor waste duty of care notes.

Approximately 2 years ago the permit was approved for NRW led variation. We have been informed by the permitting service that this permit variation will be added to the list shortly to be completed. As we discussed, this will provide you with an easier to understand and modern permit.

Nick's WAMITAB qualification expires in November 2022.

Thank you for taking the time to accompany us around the site.

Any compliance criteria not highlighted in the above summary should be considered as not assessed.
