A site inspection was undertaken on 17 August 2021 by Sally Wakeford and Michael Edwards. At the request of the Fire Rescue Service we attended alongside following the recent fire on site.

During this visit, a site inspection was carried out at the recycling site EPR/KB3097TU

The Blue MRF building has now been demolished.

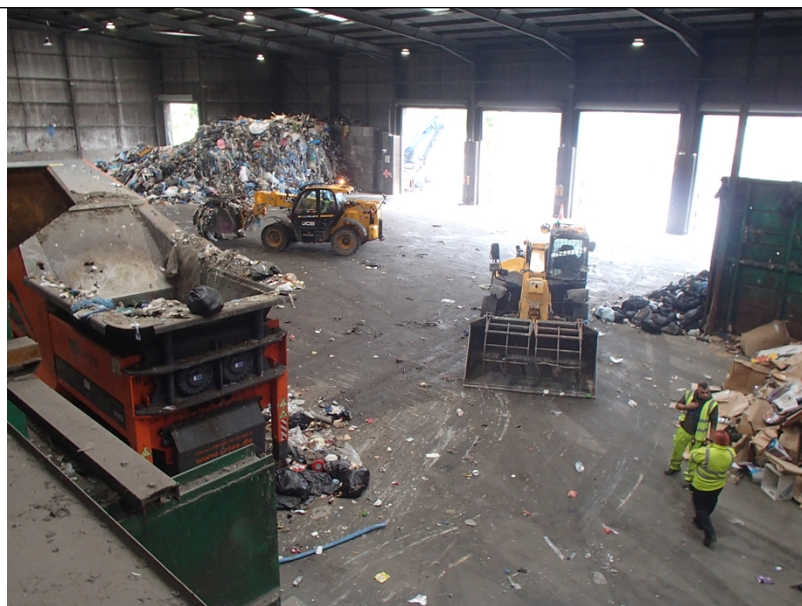
In the Black MRF the site is currently shredding black bag waste with no sorting.

The site appeared well managed with relatively small stockpiles of waste on site and the storage outside was within the storage bays.

Quarantine bin for wastes such as gas canisters was in use.

The baling area was clean and tidy with a very small amount of RDF stock in situ.
