4. Details of our assessment

On 19 October 2021 an unannounced site inspection was conducted by Sally Wakeford and Michael Edwards. There was no one on site at the time of the inspection.

The following observations were made:

The site was secure with perimeter fencing and locked gates.

It was noted that the stockpiles of various grades of aggregates appeared high quality. There was a large stockpile of mixed soil and stone to the front of the site which had started to grass over, although growth was not excessive.

A pile of green waste was observed on site. Please note that green waste is not in your list of waste codes which are allowed to be accepted on site. You have been given a **Category 3 breach of permit condition 2.3.1 (a)** for types of waste accepted onto site.

Action: you must remove any waste on site which is not allowed to be accepted under the permit by 30 November 2021.



It was also noted there was a covered skip containing green waste outside the permit boundary.
