4. Details of our assessment

A site inspection was conducted at the site on 19 October 2021 by Sally Wakeford and

Michael Edwards. We were accompanied on site by Stacey Norman.

There are currently very few inputs coming into the site at the present time as the majority of the groundworks in the Swansea area of developments have been completed.

Although aggregates are going out, some of the stockpiles are difficult to work during a period of wet weather, one stockpile was ok during times of wet weather.

There is a made bund to the right of the site, which is required under planning to ensure the protection of the trees and noise attenuation. This does take on the appearance of a stockpile, but is required to be in situ.

We were unable to access the rear of the site due to rainwater, however this ponding shows that the site was not allowing discharges to the rear of the site. The ponding will naturally disperse through seepage. Runoff from the road outside the site does appear to enter the site, and increase the volume of water on site. Stacey explained that the Council cannot locate where the road drains lead.

The site appeared well organised and stockpiles were identifiable of different waste types.

Stacey has her WAMITAB test booked for November.
