CQA Report for the installation of erosion control system and re-seeding, Bryn Posteg Landfill prepared on behalf of Sundorne Products Ltd, Version 1, Issued 17/09/21 by Torus Engineering was submitted to NRW on 08/10/21 for review as required by Permit Condition

2.6.7.

We have checked the report and can confirm that the completed works have been carried out according to the CQA Plan and as such we are satisfied.

CAR_NRW0038549 recommended that the Environmental Management System (EMS) and Site Operating Procedures (SOPs) are updated to include procedures to ensure the lagoon slopes are regularly inspected for stability which includes reporting any seepages apparent on the slope surfaces. The Operator responded in an e-mail on 10/09/21, '*We have added inspection of the lagoon slopes to our daily site checks*'.
