3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

On 27th October 2021 Natural Resources Wales (NRW) received a Schedule 6 Notification from Kennametal informing them that the emission limit value (ELV) for particulate emissions from emission point A6 had been breached. Kennametal were informed of the breach on 4th October 2021.

The measured value for particulate emissions from emission point A6 during routine monitoring on 26th August 2021 was 66.3 +/-3.2mg/m³. The ELV is 25mg/m³.

This is an on-going problem which Kennametal have been trying to solve for some time. They have now decided to replace the existing abatement equipment and the procurement process has begun. Installation should be complete by the end of February 2022.

Even though scores for breaches of the ELV for particulates emitted from A6 are currently suspended, Kennametal must continue to notify NRW of every breach of the ELV occurring at this emission point. NRW believe this incidence of late reporting was due to a misunderstanding and so a non-compliance has not been issued. However, Kennametal must ensure that their Schedule 6 Notification procedure is robust and that staff understand the necessity of using it to immediately inform NRW about breaches of permit conditions.
