This CAR form confirms acceptance of Yuasa's written request received 21st September, 2021, to amend the A1 reporting forms to reflect the stack numbers in their permit dated 07/05/2021.

Further to this, NRW received the A1 monitoring Q3 report on 12th October, 2021 for period 1st July, 2021 to 30th September, 2021. The report was submitted on time and all emission limit values (ELVs) were within their respective limits.

The reporting period for S1 is six monthly. Form S1 was also received on 12th October, 2021 and covers the period from 1st April, 2021 to September, 2021. It is noted that all parameters having ELVs at point sources S1 and S2 were within respective limits.
