4. Details of our assessment

On Wednesday 13th October, Waste Regulation Officer Sarah Walton and Hazardous

Waste Regulation Officer, Kathryn Bradshaw visited site and met with site manager, Aaron Smith.

This was a routine un-announced inspection.

Aaron explained he was in the process of applying for a WAMITAB certification. In the meantime, Marco Muia is acting as the site's Technically Competent Manager.

The site appeared in a good, orderly condition and progress was still with being made with the clearance of waste to the rear of the site.

The photo shows the storage of waste tyres and metal at the rear of the site. Aaron explained that most of the tyres were being removed from site that weekend and being taken to AC Tyres.

Aaron explained that the site occasionally accepts End of Life Vehicles (ELVs) but that they ensure all vehicles are depolluted before being accepted on site.

The shearer had been out of working order but has recently been repaired. The front part of the site had now been fully cleared and gravel had been laid ready for steel plates to be put down which will help reduce erosion to the ground.

The old building adjacent to the office is now completely fenced off and not used by site anymore due to health and safety concerns. Oils were now being stored in a designated shed on an impermeable surface with drainage to the interceptor.

Towards the end of the inspection, Waste Returns were discussed. The site still currently submits paper copies of waste returns. This means there is often a delay with these returns being received by the Regulating Officer. Evidence has been received that Quarter 1 & Quarter 2 Waste Returns for 2021 have been posted to NRW, however, these have not yet been viewed by the Regulating Officer and so cannot yet be assessed. Efforts are being made by site to move across to an electronic system to make processes more efficient. Please ensure that Quarter 3 Waste Return for 2021 is submitted by 31st October 2021.

The inspection concluded at approximately 14:15.
