4. Details of our assessment

This Compliance Assessment Report (OMA) follows a Operator Monitoring Assessment Audit covering emission from emission point W1.

The findings of the audit along with associated actions and recommendations are recorded in an OMA report titled 'OMA Water Report Warwick 19/07/21'.

The following permit non compliance was identified.

Permit condition 2.10.1 requires that monitoring is carried out in accordance with table 2.2.5 . With reference to permit variation 14 issued 05/07/18 this includes 'Total Hydrocarbon Oil' to be measured per discharge as a composite sample. This monitoring has not been carried out. At the point of writing the operator is now carrying out this analysis via an external laboratory.

Failure to monitor emissions in accordance with permit 2.10.1 attracts a CCS score of 3.
