4. Details of our assessment

Non-Compliance: One non compliance raised for this site, namely, the need to clear overgrowth/bramble to gain access to the Discharge Sampling Point and the Consent Point.

Advisory: It is advisable to improve protection around the external "inlet well" opening to prevent anyone falling in. A local resident approached us whilst on site explaining that they are getting odours from the Dwr Cymru site. It is advisable to cover the "inlet well" to minimise odour coming out of the site and affecting nearby properties.
