Quarterly Air 1 report:

NRW received the quarterly report for Q3 (Jul-Sep) on 15th October 2021.

Biomass UK No. 2 Ltd operations team notified NRW of their intent to resume operations and performance testing of their plant from 9 August 2021. The plant has not operated since April 2020. Since the 9th of August the plant has operated intermittently which is reflected in the sporadic nature of the monitoring results in the Q3 report. As a consequence, Biomass UK haven't had enough consecutive days on which to perform QAL2 and AST testing therefore were unable to complete the Air_2 form.

The releases to air for the site were assessed as being within the permit limits. All daily and ½ hourly limits were not exceeded during this quarter.

Waste returns:

Q3 2021 waste returns were received on the 4th October 2021. All entries were compliant.

Q3 In - 1,002 tonnes; Out – 14.9 tonnes
