4. Details of our assessment

Unannounced site inspection undertaken by Michael Edwards of Natural Resources Wales.

General Management

During the inspection it was noted that the site was well maintained with no debris, loose waste or litter on the yard. Drains were kept clear and the impermeable surface was in good condition with wastes stored on engineered surface in line with **condition 2.1.1**.

No leaks or spills were identified during the inspection in accordance with **condition 4.2.1**

No evidence of burning taking place on site as required under **condition 4.3.1**

Waste Storage

Waste was stored appropriately on the yard within designated skips and concrete bays, all waste was on impermeable surface with appropriate drainage in line with **condition 1.1.1** of the permit. No non permitted waste identified during the inspection in accordance with **condition 1.2.1**.

Control of Debris

No debris were identified on the road adjacent to the depot and appropriate vehicle washing facilities are available on site as required by **condition 4.1.1** and **4.1.2** of the permit.
