4. Details of our assessment

NRW officer Phil Harper visited Anglesey Aggregates, Chwarel Bwlch Gwyn, Gaerwen, Isle of Anglesey, LL60 6AA on the 8th October 2021 at 10:15 am.

The weather was dry but overcast. Ground conditions were wet following wet weather.

The site visit was conducted due to a complaint claiming that permit breaches were occurring at the site.

As a result of increased output of the Bwlch Gwyn Quarry, the processing of virgin stone has encroached onto the permitted area.

At the time of the visit there was no waste activities occurring within the permitted area with a single stockpile of waste waiting to be treated.



**C3 Materials Acceptance.**

All waste within permitted area was compliant with those listed on the permit.

C4 Storage, handling, labelling and Segregation

Stockpiles of virgin stone and product were clearly segregated from the waste stockpile on site.

E3 Surface Water

The settlement lagoon for the site was inspected. The lagoon was in working order and free from obstruction. No visible impact on water.

F1 Odour

No odours on site or outside of the site boundary.

F3 Dust/fibres/particulates and litter

No dust on site, no litter outside of the site boundary.

F4 Pests/birds and scavengers

No vermin on site.

F5 Deposits on road

No deposits or mud on the road outside the site.

No permit breaches were noted during the inspection.
