### 4. Details of our assessment

**Compliance Assessment Report (CAR1) Tradebe Bridgend Waste Management Centre: EPR/NP3233XX – 1<sup>st</sup> November 2021**

Tradebe was issued with a new permit on the 28/06/21 this was issued as a result of an NRW led variation due to the publication of the latest Waste Treatment Bref. As a result of this variation the two previous

permits GP3298FY and NP3233XX were combined into NP3233XX.

The OPRA profile was reviewed during this period and the score is now 115.

**Sewer discharge monitoring:**

Form S1 -Final Effluent Discharge – 6 monthly (Jan -June) received 26/07/2021

The results for NH3-N exceed the permit limit on a number of occasions. This is not the first incidence of this exceedance. However, this exceedance has been addressed by the previous regulatory officer in CAR\_NRW0037017 where the Trade Effluent Consent limit (TEC limit of 1500 mg/l) applies in place of the EPR permit limit. Therefore, a non-compliance has not been given. The remaining parameters are all within the current permit requirements.
